Application Requirements	<p>All applicants must:</p> <p>(1) be able to commute to Nara City.</p> <p>(2) be a native English speaker or have equivalent abilities.</p> <p>(3) have a Bachelor’s degree.</p> <p>(4) have at least one of the certifications of TESOL, TECSOL, TEFL and CELTA or have equivalent certifications or abilities.</p> <p>(5) have an experience of over 3 years teaching experiences for children or students in Japan</p> <p>(6) have Japanese-Language Proficiency Test (JLPT) N3 or above, or have equivalent certifications or abilities to teach and give guidance in Japanese.</p> <p>(7) have the appropriate type and period of visa to work for this position in Japan.</p> <p>(8) understand the education curriculum and government guidelines for</p>

Also, applicants must have the enthusiasm and abilities to perform the role as AEE.</p> <p>(9) have interest to communicate with students and teachers positively and sincerely. Disqualification	<p>A person who falls under any of the following items cannot apply for this position:</p> <p>(1) A person under guardianship or curatorship (including a quasi-incapacitated person for whom the provisions then in force remain applicable under the enforcement of the Act for Partial Revision of the Civil Code).</p> <p>(2) A person who has been sentenced on account of a crime by imprisonment or more serious punishment, and of whom the execution of the sentence has not been completed or who has not yet ceased to be amenable to the execution of the sentence;</p> <p>(3) A former public officer of Nara City who was dismissed by disciplinary action within two years of application.</p> <p>(4) A person who formed or belonged to a political party or other organization which advocated the overthrow of the Constitution of Japan or the government established under the Constitution of Japan by force.</p> <p>(5) Those who do not possess Japanese nationality and are subject to restrictions of employment by status of residence.</p> <p>(6) If an applicant has a criminal record for a specific crime (if the applicant is found guilty of a specific crime), in accordance with the Child Sexual Violence Prevention Act, measures must be taken to prevent the applicant from engaging in this work, etc. Therefore, one of the conditions for employment is that the</p>
